1. Third Amendment to the Toledo Express Airport Joint Economic Development District Contract to add territory to the district – Schedule public hearing

Trustee Jeff Michael received a petition to add five parcels to the Toledo Express Airport Joint Economic Development District. There are four parcels in Swanton Township, two on Airport and two on S. Berkey Southern and one in Monclova Township on Strayer Road. This will be a proposed Third Amendment to the JEDD Contract to add these new parcels to the District. We are required to provide public notice and hold a public hearing allowing for comment and recommendations and consideration of the proposed Third Amendment. We are required to provide thirty days' public notice of the time and place of the public hearing in a newspaper of general circulation.
